Provide training to contractors or inform a student room manager so on
an irregular basis

The University will not:

Carry out DB checks or insist on a restriction or contractors attention to
carry out a full repair without first assessing the contractors work however
required to arrange attention and carry out repairs works between 00
and 00 p.m. except in an emergency situation in which case
students aware of the requirement of contractors to arrange attention of
their normal working hours
Act in loco parentis or provide direct supervision of person
Carry out DB checks on other students – even where their students are
over 18 years of age
Monitor how the student spends their leisure time or manage their finances
